Dear Friends of ACP,

American Corporate Partners has seen a year of dynamic growth, and I am pleased to have worked with so many veterans in 2014.

In January, ACP launched a public service campaign to highlight ACP AdvisorNet and enlisted the support of several of our nation's business, political and entertainment leaders in asking fellow Americans to help serve those who have served us. ACP released five PSAs this year, beginning with a message from Johnson & Johnson Chairman and CEO, Alex Gorsky. The campaign continued throughout the year with messages from *The Daily Show* host Jon Stewart and politician Sarah Palin, WWE superstar John Cena, Former President Bill Clinton, and political consultants David Axelrod and Karl Rove. Our television and radio PSAs have increased awareness for our online community and engaged Americans in a national dialogue about careers for returning veterans.

ACP AdvisorNet also underwent a full redesign, which helped the site to grow consistently through the year. Usage of the site, as measured by sessions, doubled from 2013 to 2014, owing in part to the addition of several exciting new features. The improved Community section now showcases an interactive map to allow Veterans to find nearby Advisors in their desired career field to provide advice and expand their professional networks. A new Articles section provides the space for more detailed posts relating to veterans in the corporate world. Our Featured Questions section highlights general career development questions to engage larger numbers of veterans.

In addition to the successes of ACP AdvisorNet, ACP's Veteran Mentoring Program reached new heights as we welcomed 14 new companies, bringing the number of Participating Institutions to more than 60 organizations from a variety of industries. These new Mentors allowed us to offer opportunities to more veterans than ever – 2,100 mentorships in 2014. We now have more than 5,000 veteran Alumni who have told us that their mentorship significantly impacted their transition experience.

In 2015, we look forward to an even greater year of service to our veterans. With an estimated one million military members returning to civilian life, ACP anticipates continued growth across both the Mentoring Program and ACP AdvisorNet. We plan to meet this growth by continuing to increase our staff, partnering with additional companies and further enhancing ACP AdvisorNet. ACP began with a strong dedication to our nation's veterans, and we are excited to continue to serve those who have served us.

MISSION

American Corporate Partners (ACP) is a nonprofit organization dedicated to assisting veterans in their transition from the armed services to the civilian workforce. As the only nationwide mentoring program that pairs veterans with corporate professionals from Fortune 500 companies, ACP offers veterans the opportunity to gain the tools and skills necessary for long-term career development. ACP's free, yearlong program creates mentorships that provide career counseling, networking opportunities and civilian business-world experience.

With the belief that one-on-one relationships enhance an atmosphere of mutual understanding, respect and support, ACP aims to strengthen the connection between corporate America and veteran communities.

HISTORY

Founder Sidney E. Goodfriend launched American Corporate Partners on Labor Day 2008. With the help of six founding Participating Institutions, ACP offered 300 mentorships in select U.S. cities. Since our founding, ACP has increased the number of Participating Institutions to more than 60 companies and now offers mentorships to more than 2,100 veterans nationwide.

ACP AdvisorNet launched in 2011 and has continued to connect veterans with business leaders through an online business Q&A forum. ACP AdvisorNet has grown to include a networking Community and a library of articles to assist veterans and current service members achieve their long- and short-term career goals.

ACP'S PROGRAMS: Veteran Mentoring Program

YEARLONG

ACP's Veteran Mentoring Program is a yearlong mentorship connecting veteran Protégés with corporate Mentors from a variety of industries such as defense, logistics, project management, finance and sales.

ONE-ON-ONE

ACP's Veteran Mentoring Program provides one-on-one mentorships allowing veteran Protégés and corporate Mentors the ability to define the goals of their mentorship together. Common goals include résumé writing, networking and career advancement.

CUSTOMIZED

Each ACP Protégé and Mentor is personally paired by a dedicated Operations Associate. Protégés and Mentors are paired based upon career interests to ensure that all veteran Protégés receive the assistance and guidance they need to develop in their careers.

ACP'S PROGRAMS: ACP AdvisorNet



ACP AdvisorNet is an online Q&A forum that connects veterans with business leaders for help with their career development. Advisors play a meaningful role by offering career guidance to veterans as they transition from the military to the corporate world. ACP AdvisorNet is a space for professionals to provide career tips, review résumés and share industry knowledge. By volunteering their time to answer questions, Advisors help veterans get real advice from real professionals.



A **Direct Messaging System** helps users network with the ability to upload documents or privately ask for advice from members of the Community.

An **Interactive Map** allows users to search for Veterans or Advisors by geographic location.

The **Top 10 Companies List** features the companies with the most volunteer Advisors.

PSA CAMPAIGN

ACP AdvisorNet experienced impressive user growth this year, a success that can largely be attributed to a campaign of Public Service Announcements that ran through 2014.

2014 CAMPAIGN

Johnson & Johnson Chairman and CEO, **Alex Gorsky** announced a PSA campaign in support of ACP AdvisorNet in January. In a video produced with the help of ACP Participating Institution Omnicom, Gorsky encouraged business professionals to share their knowledge with returning veterans.

Sarah Palin & Jon Stewart took up the message in a radio PSA that began airing in April, and agreed that there is a need to help veterans start their new careers.

John Cena and WWE promoted ACP AdvisorNet to veterans in a PSA that began airing in May. Cena encouraged servicemembers to connect with corporate Advisors for help transitioning into the civilian workforce.

President Bill Clinton continued the campaign for ACP AdvisorNet and spread the message to Americans to "serve those who have served us."

David Axelrod & Karl Rove admit that while they do not agree on much, they do agree on assisting our nation's veterans in finding their next career.












ACP'S NATIONAL PRESENCE





General David Petraeus and ACP Founder and Chairman, Sid Goodfriend co-authored an op-ed published in *The Wall Street Journal* titled "Enlisting Companies to Invest in Veterans" in January. The piece highlighted the opportunities that Fortune 500 companies have to provide veterans with long-term career development tools.





In February, ACP recognized General Electric for its commitment to veterans and presented the first ACP Award for Excellence in Veteran Engagement and Integration to GE Chairman and CEO Jeffrey R. Immelt.





ACP partnered with The Mission Continues, Student Veterans of America, and Iraq and Afghanistan Veterans of America to coordinate a second television production immersion program with "The Daily Show with Jon Stewart" this spring.





PepsiCo hosted a luncheon and round-table discussion for 40 ACP Mentors and Protégés at their headquarters in Chicago, before volunteering to serve dinner for more than 325 service members and their families at the USO of Illinois.





Barclays Capital hosted two mock interview and networking events in March and October 2014. Approximately 80 ACP Protégés benefitted from two rounds of mock interviews and professional feedback from Barclays Mentors and employees.
